Schedule 13D (Amendment No. 10)

EXPLANATORY NOTE: This Amendment No. 10 to Schedule 13D amends the statement on Schedule 13D relating to shares of common stock, \$0.0001 par value (the "Common Stock") of Radius Health, Inc. (the "Issuer"), initially filed by BB Biotech AG and Biotech Growth, NV (collectively, the "Reporting Persons") with the Securities and Exchange Commission on June 3, 2011 (together with all amendments thereto, this "Schedule 13D").

Each capitalized term used and not defined herein shall have the meaning assigned to such term in prior amendments to this Schedule 13D. Except as otherwise provided herein, each Item of this Schedule 13D remains unchanged.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 is hereby supplemented to add the following:

Between September 15, 2017, and July 27, 2018, the Reporting Persons acquired an additional 695,000 shares of the Issuer's Common Stock (the "Fourth Additional Open Market Shares") on the open market and exercised the Biotech Growth Warrant on April 12, 2018 pursuant to which the Reporting Persons received an additional 107,114 shares of the Issuer's Common Stock (the "Warrant Shares"). The aggregate increase of 802,114 shares held by the Reporting Persons resulted in an approximate 1.0% increase in percentage ownership of the outstanding shares of the Issuer's Common Stock held by the Reporting Persons since the filing of Amendment No. 9 to this Schedule 13D with the Securities and Exchange Commission on September 20, 2017. Each of the purchases of the Fourth Additional Open Market Shares and the exercise of the Warrant Shares were made with the working capital of BB Biotech and the aggregate amount of funds expended, excluding commissions, to acquire (i) the Fourth Additional Open Market Shares was US \$21,205,886.50 and (ii) the Warrant Shares was US \$1,500,024.46.

Item 4. Purpose of Transaction

Item 4 is hereby supplemented to add the following:

The Reporting Persons acquired the Fourth Additional Open Market Shares and the Warrant Shares for investment purposes.

Item 5. Interest in Securities of the Issuer

Item 5 is hereby amended and restated in its entirety as follows:

- (a) Assuming the exercise of the Biotech Growth New Warrant, Biotech Growth is the record owner of 6,372,322 shares of Common Stock. To the best knowledge of BB Biotech and Biotech Growth, no director or executive officer of BB Biotech or Biotech Growth owns any shares of the Common Stock.
- (b) Regarding the number of shares as to which such person has:
 - (i) sole power to vote or to direct the vote:

 - (ii) shared power to vote or to direct the vote:

 - (iii) sole power to dispose or to direct the disposition:

- (c) Except as set forth in Item 3 above, none of the Reporting Persons has effected any transaction in the Common Stock of the Issuer during the last 60 days. To the best knowledge of the Reporting Persons, no director or executive officer of BB Biotech and Biotech Growth has effected any transaction in the Common Stock during the last 60 days.
- (d) No other person is known to have the right to receive or the power to direct the receipt of dividends from, or any proceeds from the sale of, shares beneficially owned by any of the Reporting Persons.
- (e) Not Applicable.
